SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

4.2. Most Important Symptoms and Effects Both Acute and Delayed

General: May cause respiratory irritation. May cause cancer (Inhalation). Causes damage to organs (lungs) through prolonged or repeated exposure (Inhalation). Skin sensitization. Causes severe skin burns and eye damage.

Inhalation: Irritation of the respiratory tract and the other mucous membranes. Dust may be harmful or cause irritation.

Skin Contact: When this product is wet it is corrosive. Cement may cause dry skin, discomfort, irritation, severe burns, and dermatitis. Exposure of sufficient duration to wet cement, or to dry cement on moist areas of the body, can cause serious, potentially irreversible damage to skin, eye, respiratory and digestive tracts due to chemical (caustic) burns, including third degree burns. A skin exposure may be hazardous even if there is no pain or discomfort. Cement is capable of causing dermatitis by irritation and allergy. Skin affected by dermatitis may include symptoms such as, redness, itching, rash, scaling, and cracking. Irritant dermatitis is caused by the physical properties of cement including alkalinity and abrasion. Allergic contact dermatitis is caused by sensitization to hexavalent chromium (chromate) present in cement. The reaction can range from a mild rash to severe skin ulcers. Persons already sensitized may react to the first contact with cement. Others may develop allergic dermatitis after years of repeated contact with cement.

Eye Contact: Concrete may cause immediate or delayed irritation or inflammation. Eye contact with wet concrete can cause moderate eye irritation, chemical burns and blindness. Eye exposures require immediate first aid and medical attention to prevent significant damage to the eye.

Ingestion: May cause burns or irritation of the linings of the mouth, throat, and gastrointestinal tract.

Chronic Symptoms: May cause cancer (Inhalation). Causes damage to organs (lungs) through prolonged or repeated exposure (Inhalation). Long term exposure to respirable crystalline silica results in a significant risk of developing silicosis and other non-malignant respiratory disease, lung cancer, kidney effects, and immune system effects.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Suitable Extinguishing Media: Use extinguishing media appropriate for surrounding fire.

Unsuitable Extinguishing Media: Do not use a heavy water stream. Use of heavy stream of water may spread fire.

5.2. Special Hazards Arising From the Substance or Mixture

Fire Hazard: Not considered flammable but may burn at high temperatures.

Explosion Hazard: Product is not explosive.

Reactivity: Calcium oxide reacts with water to form corrosive calcium hydroxide, with evolution of much heat. Temperatures as high as 800° C (1472 °F) have been reached with addition of water (moisture in air or soil). Quartz (silica) will dissolve in hydrofluoric acid producing a corrosive gas, silicon tetrafluoride.

5.3. Advice for Firefighters

Precautionary Measures Fire: Exercise caution when fighting any chemical fire.

Firefighting Instructions: Use water spray or fog for cooling exposed containers.

Protection During Firefighting: Do not enter fire area without proper protective equipment, including respiratory protection. **Hazardous Combustion Products**: Carbon oxides (CO, CO₂). Crystalline silica exists in several forms, the most common of which is quartz. If crystalline silica (quartz) is heated to more than 870°C (1598 °F), it can change to a form of crystalline silica known as trydimite, and if crystalline silica (quartz) is heated to more than 1470°C (2678 °F), it can change to a form of crystalline silica known as cristobalite. The OSHA PEL for crystalline silica as trydimite and cristobalite is one-half of the OSHA PEL for crystalline silica (quartz).

SECTION 6: ACCIDENTAL RELEASE MEASURES

6.1. Personal Precautions, Protective Equipment and Emergency Procedures
