Installation:

LATICRETE 9235 Waterproofing Membrane must be installed in accordance with the manufacturer's published instructions and the applicable code(s).

Ceramic tile must comply with ANSI A137.1

Drains must have a clamping ring with open weep holes in accordance with ASME A112.6.3.

### Models: LATICRETE 9235 liquid

A ready-to-use, 54-percent-solids, formulated, styrene butadiene, rubber-based latex, packaged in 6-gallon (22.7 L) pails.

### LATICRETE 9235 reinforcing fabric

A 2.4-ounce-per-square-yard (75.7 g/m<sup>2</sup>) fabric for use as reinforcement in the LATICRETE 9235 Waterproofing Membrane. The fabric is provided in 300-square-foot (27.9 m<sup>2</sup>) rolls.

### LATICRETE 9235 reinforcing tape

A 2.4-ounce-per-square-yard (75.7 g/m<sup>2</sup>) fabric for use in preparing joints and cracks of the substrate before application of the LATICRETE 9235 Waterproofing Membrane. The tape is provided in 6-inch-wide-by-75-foot-long (152 mm by 22 860 mm) rolls.

## LATICRETE Latasil Tile and Stone Sealant

A silicone sealant for use with penetrations that come in contact with the LATICRETE 9235 Waterproofing Membrane. The sealant is provided in 10.3-ounce (305 mL) cartridges.

Conditions of Listing:

- 1. Application is limited to ceramic tile and dimension stone installations on floors, and to use as shower sub-pans or lining.
- Control joints greater than 1/8 inch (3 mm), structural cracks and expansion joints with vertical differential movement used with the LATICRETE 9235 Waterproofing Membrane are outside the scope of this report.
- 3. LATICRETE 9235 Waterproofing Membrane is manufactured in Bethany, Connecticut, under a quality control program with annual surveillance inspections by ICC-ES.
