SECTION 4: FIRST AID MEASURES

4.1. Description of First-aid Measures

4.2. Most Important Symptoms and Effects Both Acute and Delayed

General: Not expected to present a significant hazard under anticipated conditions of normal use.

Inhalation: Prolonged exposure may cause irritation. This product contains Crystilline Silica dust that is mixed with a liquid to form a paste mixture, and therefore the dust is not likely to be dispersed into the air. If dust is released into the air, repeated exposure to respirable (airborne) crystalline silica dust may cause lung damage in the form of silicosis, lung cancer, or respiratory irritation.

Skin Contact: Prolonged exposure may cause skin irritation.

Eye Contact: May cause slight irritation to eyes. **Ingestion:** Ingestion may cause adverse effects.

Chronic Symptoms: Contains Crystalline Silica (quartz): As quartz is bound in a polymer matrix, it is not expected to be available as an airborne hazard under normal condition of use. If dust is released into the air, repeated exposure to respirable (airborne) crystalline silica dust may cause respiratory irritation, lung damage in the form of silicosis, and cancer. Titanium dioxide is bound in the fabric and is not able to become airborne. Thus, the hazards usually associated with titanium dioxide are not applicable to this product.

4.3. Indication of Any Immediate Medical Attention and Special Treatment Needed

If exposed or concerned, get medical advice and attention. If medical advice is needed, have product container or label at hand.

SECTION 5: FIRE-FIGHTING MEASURES

5.1. Extinguishing Media

Protection During Firefighting: Do not enter fire area without proper protective equipment, including respiratory protection.
