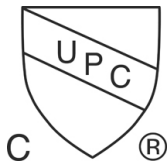

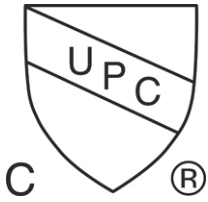
### Characteristics:
